Due to State of New Hampshire requirements the following needs to be added to our by-laws. This will be discussed at the September Meeting and Voted upon at the October Meeting.

Addendum To Application For Registration
NH Charitable Trusts Form NHCT-1

The following paragraph is suggested language only and is offered here to assist you in preparing provisions for a conflict of interest policy (#7) and dissolution (#4).

Sample

Any possible conflict of interest on the part of any member of the Board, officer or employee of the Corporation, shall be disclosed in writing to the Board and made a matter of record through an annual procedure and also when the interest involves a specific issue before the Board. Where the transaction involving a board member, trustee or officer exceeds five hundred dollars (\$500) but is less than five thousand dollars (\$5000) in a fiscal year, a two-thirds vote of the disinterested directors is required. Where the transaction involved exceeds five thousand dollars (\$5000) in a fiscal year, then a two-thirds vote of the disinterested directors and publication in the required newspaper is required. The minutes of the meeting shall reflect that a disclosure was made, the absence from voting, and the actual vote itself. Every new member of the Board will be advised of this policy upon entering the duties of his or her office, and shall sign a statement acknowledging, understanding of the agreement to this policy. The Board will comply with all requirements of the New Hampshire law in this area and the New Hampshire requirements are incorporated into and made a part of this policy statement.
